FCC TO CONSIDER ENHANCED DISCLOSURE IN UPCOMING OPEN MEETING

At the FCC's next open meeting, scheduled for tomorrow, Thursday, October 27, 2011, the Commission will consider, among other things, certain issues lingering from the long-dormant "localism" proceeding.

As you know, the Commission in late 2007 adopted a number of wide-ranging rules related to broadcast localism. For example, the "enhanced disclosure" rules adopted in 2007 would require broadcasters to complete cumbersome standardized program-related forms each quarter and to make their local public inspection files available on the Internet. These rules have been under legal challenge by the broadcast industry at the Commission and in federal court. The rules have not been in effect due to the ongoing litigation.

At the October 27 meeting, the FCC is expected to adopt an *Order on Reconsideration of the 2007 Enhanced Disclosure Report and Order* ("*Order*") and a *Further Notice of Proposed Rulemaking* ("*Notice*") related to the proposals adopted in 2007. The *Future of Media* report, which was prepared by Commission staff and released earlier this year, recommended that the standardized "enhanced disclosure" form be discarded. According to new reports, the *Order* is expected to vacate the rules adopted in 2007. Moreover, based on the public notice announcing the meeting schedule, it appears the Commission may propose in the *Notice* to require stations to maintain some portion of their public inspection files on a website to be hosted by the FCC.

Details of the *Order* and *Notice* are not yet publicly available. We will be monitoring the Commission's October 27 meeting and will provide stations with more information following the meeting.

PETITION ASKS FCC TO ALLOW FLEXIBILITY FOR NON-RESERVED BAND FM STATIONS

The FCC recently received a *Petition for Rulemaking* ("*Petition*") requesting that the Commission amend its rules to allow non-reserved band FM stations some of the same flexibility and contour protection that the rules provide to reserved band noncommercial educational facilities. Such a rulemaking would have potential benefits for commercial broadcast stations if the Commission adopts rules to simply the construction permit application process as requested in the *Petition*. The highlights of the requests in the *Petition* are discussed below.

First, the *Petition* calls for the FCC to eliminate the "Proposed Allotment or Assignment Coordinates" requirements for non-reserved band FM minor modification

applications within the FCC's construction application form (FCC Form 301). The *Petition* argues that the current application process is burdensome for commercial non-reserved band facility licensees and permittees who must identify a fully-spaced allotment site which may or may not be relevant to the actual antenna location. No other radio broadcast service is required to identify such a site.

The *Petition* next calls for an important change to the rules regarding contour protection. The *Petition* proposes that the rules be amended to require an applicant submitting a minor modification application to the FCC to protect only the *actual facilities* of neighboring co-channel and adjacent channel facilities, rather than hypothetical maximum facilities. In other words, the FCC would consider the *actual* antenna height and effective radiated power levels of neighboring co-channel and adjacent channel stations.

Finally, the *Petition* proposes removing a section of the rules regarding minimum distance separation requirements to afford greater flexibility to non-reserved band FM stations. The current rules impose minimum distance separation standards which, the *Petition* argues, were adopted decades ago out of an abundance of caution. The *Petition* argues that the FCC should now relax its rules given the availability of technology and an improved understanding of how directional antennas actually work.

It remains to be seen whether the FCC will initiate a rulemaking regarding the *Petition*'s proposals. We will continue to keep you apprised of any developments.

AUCTION OF FM BROADCAST CONSTRUCTION PERMITS SCHEDULED FOR MARCH 27, 2012

The FCC has announced the auction of certain FM broadcast construction permits to begin on March 27, 2012. The specific vacant FM allotments up for auction are listed in Attachment A to this *Legal Memorandum*. There is only one Virginia construction permit involved. That construction permit is for a Class A station in Iron Gate, Virginia, with a proposed minimum opening bid of \$25,000.

FCC TO PERMIT ENERGY-SAVING TRANSMITTER TECHNOLOGY FOR AM STATIONS

The FCC recently announced that it will permit AM stations to use transmitter technologies that reduce power consumption, known as Modulation Dependent Carrier Level ("MDCL") control technologies or algorithms. Accordingly, the Commission has established procedures for AM broadcasters to seek a rule waiver in order to use MDCL

technology on a voluntary basis to save power. The FCC reports that MDCL technology can reduce power consumption of an AM transmitter by 20 to 40 percent, with largely imperceptible effects on audio quality.

Upon approval of a waiver request, the FCC will issue the station a modified license, indicating that a waiver has been granted to permit use of a specific MDCL technology causing transmitter power to drop below 90 percent of the station's licensed power.
